#### OFFICIAL RULES - California Golden Owl Award® Contest

#### **ELIGIBILITY**

Nominees must be California-licensed educators currently teaching agricultural education courses at the secondary (middle/high school). **No purchase is necessary**.

Nominations can be submitted by the general public, current or former students, parents, fellow educators, school administrators and community members.

#### TEACHERS MAY NOT SELF-NOMINATE.

Employees, affiliates, subsidiaries, advertising and promotion agencies, and any entity involved in the development, production, implementation, administration or fulfillment of the Contest (all of the foregoing, together with Nationwide, and California FFA collectively referred to as "Promotion Entities") and their immediate family members and/or those living in the same household of such persons, whether related or not, are not eligible to enter the Contest.

# **HOW TO ENTER**

The Nomination period begins September 2, 2025 and ends January 16, 2026 at 11:59 p.m. PST ("Nomination Period").

To enter, provide your and the ag teacher's contact information, including an essay (250 words or less) describing how the teacher's dedication to agriculture education, and commitment and impact on today's youth make the teacher the best in the state.

Nominations can be completed online at: www.calaged.org.

Entry constitutes consent to participate in the Contest and for the California FFA to obtain, use, and transfer the entrant's name, address and other details for Contest administration purposes. California FFA will not be responsible for lost, incomplete, illegible, late, misdirected, stolen, or mutilated entries; technical or mechanical malfunctions; errors in the Official Rules, in any related ads or materials; or processing error. California FFA can void the entry of any Entrant who it believes has attempted to tamper with or impair Contest administration, security, fairness, or proper play.

## **HONOREE DETERMINATION**

Six Honorees will be selected by an established committee.

An established committee will evaluate nominations received and select six Regional Honorees as defined by California FFA's regions. Nominations will be judged based on the following criteria:

- 1. Teacher's dedication to agriculture education
- 2. Teacher's commitment to his/her student(s)
- 3. Teacher's impact on his/her student(s)
- 4. Teacher's impact on their local community
- 5. Teacher's impact on the agriculture industry

Six Regional Honorees will be announced on or before March 2, 2026.

## **GRAND PRIZE WINNER DETERMINATION**

Each of the six Regional Honorees will be required to complete a supplemental nomination form, one of whom will be chosen as the overall State winner. This completed form will be due by March 2, 2026.

Ahead of the 2026 California FFA State Convention, the committee will review supplemental nomination forms submitted and select the winner of the California Agricultural Educator of the Year. That individual's name will not be released until the 2026 California FFA State Convention held March 21-24, 2026 in Ontario, California. There the new California Agricultural Educator of the Year will be announced.

If a Prize winner is not eligible to win, or if California FFA is unable to contact the winner after a reasonable effort, the prize will be forfeited, and an alternate winner may be selected. Odds of winning depend on the number of eligible entries received.

# SPONSORS ARE NOT RESPONSIBLE FOR TRAVEL-RELATED EXPENSES ASSOCIATED WITH PRIZE ACCEPTANCE.

## **PRIZES**

Prizes will be awarded as follows:

- 1. One (1) Grand Prize Winner: Trophy and \$3,000 cash prize to winner
- 2. Six Honorees: Plaque and \$500 cash prize to honoree

Prizes are non-transferable, and no substitution will be made except as provided herein at the Sponsors' sole discretion. Sponsors reserve the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason.
